

2019-2020 Signage/Awning Grant Program

Introduction

As business owners in the City of Rahway, we realize how difficult it is to keep a business afloat and your hard work and dedication to the economic viability of our community is greatly appreciated. The Rahway Arts + Business Partnership is sponsoring a Business Signage & Awning Grant Program which is intended to stimulate improvement to the exterior of commercial spaces in the Downtown Special Improvement District.

Grant Details

Grant assistance may not exceed \$2,000 per applicant or 50% of eligible expenses, whichever is **less**, for eligible projects that meet the guidelines stated within and as funding exists. Grants are provided on a reimbursement basis.

For example:

If the total project costs \$4,000; the grant award will be half that amount: \$2,000 If the total project costs \$600; the grant award will be half that amount: \$300 Projects that cost more than the \$2,000 are eligible for the grant, but the award will be capped at \$2,000.

Awards granted each year will total \$25,000. Grant Program is January 1st 2019 - January 31st 2020.

Eligibility Guidelines

Applicant must have a brick-and-mortar site in the Rahway Downtown Special Improvement		
District		
This program is for exterior signage only which includes:

	Signage in any window or doors.	
	Awnings.	

Applicant may only have one (1) grant application per Grant Program Year and the project must be completed before you can be considered for a second project.
